## 4. FIRST AID MEASURES

Slippery when wet. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. After cleaning, flush away any residual traces with water.

## 7. HANDLING AND STORAGE

Avoid skin and eye contact and breathing in dust. Avoid handling which leads to dust formation. May form flammable dust clouds in air. Keep out of reach of children.

Store in a cool, dry, well ventilated place. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for spills.
