DIRECTIONS FOR USE

Situation	Rate	Critical Comments
Sugarcane Sets	200mL per 200L of water (0.1% solution)	Make up a solution of the dip. Dip the set in the solution immediately after cutting ensuring thorough coverage. Shake off any excess solution and replenish the made up dip regularly.
Ornamental cuttings, pipings and transplants	10 mL per 10L of water (0.1% solution)	Make up a solution of dip. Dip the cuttings or transplants in the solution prior to planting.
Lawns and Golf Greens grown from: - clippings, scarifying shavings, tynings and roll out turf	100 mL per 100 L of water per 100m2 (0.1% solution)	Apply a solution of Growth Formula evenly over the area. A second application may be beneficial.
Turf, Playing Fields, Ovals etc.	10 L in 10,000 L of water per hectare (0.1% solution)	Apply a solution of Growth Formula evenly over the area.
